

TRADE NOTICE NO. 12/2008

Sub: Re-organisation of the work relating to Service Tax - reg.

Attention of the Trade, Industry and Service Tax payers is invited to the Trade Notice No. 24/2003 (No. 02/SERVICE TAX/2003) dtd. 22-10-2003 and subsequent orders/instructions issued by this office from time to time.

2. For the convenience of the trade, industry and service tax payers and smooth working, the service tax work/function and jurisdiction of officers is re-organised as below:

(i) Service Tax matters of assesseees falling within the territorial jurisdiction of the outside Ranges situated at Malegaon, Manmad, Sinnar, Sangamner, Amalner and Dondaicha will be looked after by the respective Central Excise Range Superintendents and the Assistant/Deputy Commissioners.

(ii) Service Tax matters of assesseees in the districts of Dhule (except the jurisdiction of Central Excise Dondaicha Range) and Nandurbar will be looked after by Superintendent (Service Tax) stationed at Dhule.

(iii) Service Tax matters of assesseees in the district of Jalgaon (except the jurisdiction of Central Excise Amalner Range) shall be looked after by Superintendent Service Tax Cell, Jalgaon.

(iv) Service Tax matters of all other assesseees in the jurisdiction of the Commissionerate shall be looked after by the Deputy Commissioner, Service Tax, having his office situated at:

Survey No. 925, Above ICICI ATM,
Near Samarth Mangal Karyalay,
Ambad Police Station Road, Mumbai Agra Road,
Nashik- 422 009.

3. The assesseees will have to file the ST-3 returns in their respective Ranges, who will scrutinize/assess them. Issue of any notice for demand, its adjudication or any other action to be taken under the law shall be the responsibility of the concerned Superintendent and Assistant/Deputy Commissioner.

4. Different concerned Assistant/Deputy Commissioner will send/submit prescribed Monthly/Quarterly reports to the Deputy Commissioner, Service Tax, who will monitor, compile and send them to the formations/offices as required.

5. This new arrangement will supersede all other orders/trade notice in this regard and shall come into force from 1st of October, 2008.

6. All the Trade Associations and Chamber of Commerce & Industry are requested to bring the contents of this Trade Notice to their members/constituents in particular and trade/service providers in general.
